



- (x) That, the supporting and other staff will be appointed as per the guidelines of the State Govt./the affiliating University.
- (xi) That the institution shall charge only such fee as prescribed by the affiliating body/State Govt. concerned in accordance with provision of NCTE (guidelines for Regulations of tuition fees and other fees chargeable by unaided teacher education institutions/Regulations, 2002, as amended from time to time and shall not charge donations, capitation fee etc. from the students.
 - (xii) That, the academic and other staff of the institution (including part time staff) shall be paid such salary as may be prescribed by the concerned State Govt. from time to time through Bank.
 - (xiii) That the management shall discharge the statutory obligations relating to provident fund, pension, gratuity etc. in respect of all its employees.


